

Direct Parent Loan for Undergraduate Students (PLUS) 2025-2026

Instructions

- 1. Students should complete the Free Application for Federal Student Aid (FAFSA) online at <u>studentaid.gov/fafsa</u>. Lakeland's federal school code is 006804.
- 2. Return the completed Direct Parent Loan for Undergraduate Students (PLUS) Request and Authorization Form (Page 2) to Lakeland's Financial Aid Office (FAO).
- 3. The FAO will calculate loan eligibility based on federal and institutional guidelines.
- 4. Once the PLUS loan has been awarded, the FAO will forward the information to the U.S. Department of Education (ED) and send an email to the student's Lakeland email.
- 5. If one is needed, the parent must complete a PLUS Loan Master Promissory Note online at studentaid.gov.
- 6. ED will review the parents' credit history. If the PLUS loan is denied based on adverse credit, ED will send a letter to the parent giving reasons for the denial.
- 7. If parent has an adverse credit history, parent may still receive a Direct PLUS Loan via one of these two options:

Option 1: Obtaining an *endorser* who does not have an adverse credit history. If you are a parent borrower, the endorser cannot be the child on whose behalf you are borrowing. **Option 2**: Documenting to the ED's satisfaction extenuating circumstances relating to your adverse credit history.

Once parent has completed either Option 1 or Option 2 above, parent must also complete PLUS credit counseling at <u>studentaid.gov</u>.

- 8. If the PLUS loan is approved, ED will send a disclosure statement to the parent. The loan funds will be sent to Lakeland electronically and applied to the student's account. The student must meet the eligibility requirements at the time the funds are applied to the student's account (enrolled at least half-time, not in default, etc.)
- 9. Once the funds are applied to the student's account, any remaining credit balance will be issued to the student (per the terms outlined on the Direct PLUS Loan Request and Authorization Form) within 14 days beginning with the third week of the semester. Refund checks are sent via United States postal mail unless the student has enrolled in direct deposit (eRefunds) through myLakeland.

If the parent would like the credit balance issued to them, they must contact Lakeland's Financial Aid Office to arrange that before the refund is issued.

Direct Parent Loan for Undergraduate Students (PLUS) Request and Authorization Form 2025-2026

Parents can borrow funds to cover educational costs for their undergraduate dependent student(s). Students must be enrolled in a minimum of six credit hours in an approved program and meet the eligibility established by federal regulations. Repayment begins once the loan is fully disbursed (paid out). However, you may request deferment while your child is enrolled half-time (6 credits) and for an additional six months after your child graduates, leaves school or drops below half-time. Financial need is not required to be eligible to receive funds from the Direct PLUS Loan program. However, total financial aid, including Direct PLUS loan, cannot exceed the cost of education as established for the student attending Lakeland Community College. The applicant's credit history will be evaluated in determining loan eligibility. For more information regarding Direct PLUS loans, including the current fixed interest rate, visit studentaid.gov.
